President signs executive order on rural health, telehealth access

On Aug. 3, President Trump signed an [executive order](#) on “improving rural health and telehealth access,” with directives to:

- Create a report describing policy initiatives to improve rural health.
- Develop and implement a strategy to improve rural health care infrastructure.
- Launch a new payment model for rural health care.
- Propose regulation that would extend certain telehealth flexibilities.

Due dates for cost reports extended

The Iowa Medicaid Enterprise Provider Cost Audit Unit has extended the due dates of cost reports following the revised guidance issued by the Centers for Medicare and Medicaid Services. Click [HERE](#) for a list of cost report fiscal year ends, the original cost report due date and the extended cost report due date.

This is a blanket extension; providers do not need to submit written requests. If cost reports are completed sooner, they can be submitted any time before the extended due dates.
