IHA shifting to daily email reminders for data-entry

Since April 4, when Gov. Kim Reynolds signed a mandatory order requiring hospitals to report bed tracking and personal protective equipment data through EMResource, IHA has followed up with daily emails and telephone calls to hospitals that have not entered their data by 10 am. Starting Wednesday, June 24, IHA will no longer reach out to hospitals that have not entered data by 10 am. Instead, IHA will send daily data-entry email reminders at 9:45 am to all hospitals. AHA urges HHS to extend public health emergency

The AHA yesterday urged the Health and Human Services secretary to extend the public health emergency beyond its Saturday, July 25, expiration date so "health care providers can continue to offer the most efficient and effective care possible during the continuing COVID-19 pandemic." House Democrats introduce infrastructure bill with funding for hospitals

House Democratic leaders today released legislative text for the Moving Forward Act ([H.R. 2](#)), a more than \$1.5 trillion plan to rebuild American infrastructure, including roads, bridges, transit, housing and health care.

Specifically, the bill would provide \$10 billion in total funding for fiscal years 2021 through 2025 for the construction and modernization of hospitals and medical facilities. It prioritizes awards for projects that include modernization for public health preparedness or protecting against cybersecurity threats.

Among the other health care-related provisions, the bill invests \$30 billion to upgrade hospitals to increase capacity and strengthen care; helps community health centers respond to COVID-19 and future public health emergencies; improves clinical laboratory infrastructure; supports the Indian Health Service's infrastructure; and increases capacity for community-based care.

The bill also includes two AHA-supported provisions that would restore the ability for governments, hospitals and others to advance refund tax-exempt municipal bonds, as well as revise the definition of qualified small issuers by increasing the bank-qualified borrowing limit from \$10 million limit to \$30 million.

National clearinghouse provides PPE outlet

Project N95 ([ProjectN95.org](#)) is the national COVID-19 clearinghouse for personal protective equipment (PPE) and other critical medical equipment. The rapid-response nonprofit organization's mission is to quickly get critical equipment into the hands of front-line workers.

Project N95 helps support front-line workers by:

- Coordinating with governments and other purchasers to aggregate orders and help COVID-19 response teams to source, procure and equitably distribute critical medical equipment.
- Performing due diligence on suppliers and products to accelerate procurement and sourcing decisions.
- Processing and validating inbound organization requests for PPE and critical equipment to intelligently match [vetted suppliers and products](#).
