House Democrats unveil \$3 trillion COVID-19 relief package

House Democrats today [unveiled](#) the Health and Economic Recovery Omnibus Emergency Solutions (HEROES) Act – a \$3 trillion COVID-19 relief package. Among other health care-related provisions, the package would:

- Eliminate cost-sharing for COVID-19 treatment in most forms of health care coverage.
- Increase the amount of funding available to providers through the Public Health and Social Services Emergency Fund and establish a new distribution methodology.
- Modify the terms of accelerated and advanced payments available through the Medicare program.
- Temporarily increase funding to states by increasing their federal medical assistance percentage by 14% and Medicaid disproportionate share hospital allotments by 2.5%.

The House is expected to vote on the bill Friday, and the Senate is not expected to take up the bill in its current form.

Treasury updates Paycheck Protection Program FAQ

The US Treasury Department has released an [updated FAQ](#) for the Paycheck Protection Program. The updated section deals with safe harbors and how the Treasury Department will approach compliance.

FEMA revises policy covering costs eligible for public assistance

FEMA recently released [updated guidelines](#) for COVID-19 medical care costs eligible for public assistance. The update clarifies public assistance application eligibility for state, local, tribal and territorial government entities and certain private nonprofit organizations. The policy applies to eligible public assistance applicants only, and it is exclusive to emergency and major disaster declarations for the COVID-19 pandemic.

Today, the Board of Pharmacy [announced](#) the criteria that pharmacist-interns must meet to obtain licenses to practice pharmacy in Iowa. The announcement contains eligibility criteria, limitations and information on the duration of the license.

Reminder: 340B hospital survey closes May 15

The 340B hospital survey will close Friday, May 15. This survey is for hospitals paid under the Outpatient Prospective Payment System that were enrolled in the 340B program during calendar year Q4 2018 and/or Q1 2019. Both [detailed and quick survey methods](#) are available to submit 340B-acquired drug acquisition cost information to CMS.

Both apps can be deployed in as little as 72 hours and provide timely push notifications and alerts to convey breaking news, updates and customized facility information.
