## HHS unveils COVID-19 vaccine distribution strategy

The Department of Health and Human Services today [released its strategy](#) for the public distribution of a COVID-19 vaccine. The strategy, which was developed with the Department of Defense and the Centers for Disease Control and Prevention, provides a [distribution overview](#) and an [interim playbook](#) for state, tribal, territorial and local public health programs and their partners.

The strategy identifies tasks that the COVID-19 vaccine program will require:

- Distribute vaccines immediately after granting emergency use authorization/biologics license applications using a transparently developed, phased allocation method based on the CDC's vaccine recommendations.
- Engage with state, tribal, territorial and local partners, other stakeholders and the public to communicate public health information about the vaccine and promote vaccine confidence and uptake.
- Ensure the safe administration of vaccines and the availability of administration supplies.
- Monitor necessary data from the vaccination program through an information technology system capable of supporting and tracking distribution and administration.

## HHS anticipates remdesivir ordering-process transition in October

Since June 28, HHS has worked with Gilead Sciences, state departments and AmerisourceBergen to allocate and distribute remdesivir to hospitals. HHS and state department involvement in the allocation process has helped ensure hospitals have access to the drug while production capacity is increased.

Its anticipated that **Friday, Oct. 2**, will be the last day state departments will place remdesivir orders for hospitals. After this date, its expected HHS and state departments will no longer be involved in the allocation process and that hospitals can place remdesivir orders using traditional ordering processes.

## Republican COVID-19 relief bill fails to advance in the Senate

A roughly [\\$500 billion COVID-19 relief package](#) failed to advance in the Senate last week as it fell short of receiving the necessary 60 votes. The vote on the legislation was 52-47. Republican leaders introduced the package, which would have provided additional assistance for priorities, including small businesses, enhanced unemployment insurance, childcare, COVID-19 testing and schools. The legislation also would have provided liability protections from certain lawsuits related to COVID-19.

## IRS issues initial guidance on deferral of employee portion of Social Security tax

The Internal Revenue Service recently [issued guidance](#) for implementing the White House's Aug. 8 executive order on payroll taxes, which applies to wages paid Sept. 1 through Dec. 31. Under the memorandum, nonfederal employers may defer withholding and payment of an employee's portion of the Social Security tax if the employee earns less than \$4,000 biweekly. These taxes must be repaid between Jan. 1 and April 30, 2021, or interest, penalties and additions to tax will begin to accrue on May 1, 2021. This differs from the CARES Act payroll tax delay of the [employer share](#), which began March 27 and allows repayment over a two-year period.

## IDPH provides rural health information updates

IDPH has recently provided these COVID-19 resources for rural health stakeholders:

- [Rural Crosswalk for COVID-19 waivers and flexibilities](#): CMS publishes a summary of COVID-19-related waivers and flexibilities that affect rural health clinics, federally qualified health centers, critical access hospitals and skilled nursing facilities. It also describes the significance of each provision for these rural providers and facilities.
- [Rural EMS COVID-19 Preparedness Checklist](#): Provides a checklist for rural response agencies to evaluate their current level of preparedness and identify areas that need additional action to better respond to COVID-19. Covers planning, strategy, personal protective equipment and supplies, workforce and recruiting, and funding.
- [Health Conditions and an Older Population Increase COVID-19 Risks in Rural America](#): Examines the influence of age and pre-existing health conditions on the likelihood of hospitalization or death from COVID-19 infection in rural America. Compares COVID-19 case rates and deaths by metropolitan status. Includes county-level maps on estimated risks among those infected with COVID-19 and current incidence.
- [Lessons Learned: Pediatric Tele-Mental Health in a Rural Medical Center in the Age of SARS-CoV-2](#): Explores a study on the use of telemedicine to expand mental health care access to rural children during the COVID-19 pandemic. Discusses implementation concerns such as a need to protect patient privacy and expand internet-based infrastructure.
- [America at a Glance: Social Isolation and Loneliness During the First Wave of COVID-19](#): Explores how COVID-19 and related stay-at-home orders contributed to feelings of social isolation and loneliness among people with disabilities. Compares feelings of social isolation and loneliness among urban and rural groups before and after the COVID-19 pandemic. Discusses the possible impact of technological accommodations on these feelings.
- [COVID-19 Response in Minority Communities](#): 11 am, Thursday, Sept. 17. This virtual symposium is hosted by the HHS Office of Minority Health and will highlight state, tribal, territorial and community-based efforts to address COVID-19 among racial and ethnic minority populations.
