Governor issues proclamation about nonessential elective surgeries and procedures

Gov. Kim Reynolds today issued a proclamation that included provisions about nonessential or elective surgeries and procedures. IHA is further evaluating the proclamation and will be providing additional guidance on nonessential or elective surgeries and procedures next week. SBA issues interim final rule on PPP eligibility for public hospitals

Today, the Small Business Administration released an [interim final rule](#) stating that "a hospital that is otherwise eligible to receive a Paycheck Protection Program loan as a business concern or nonprofit organization (described in section 501(c)(3) of the Internal Revenue Code of 1986 and exempt from taxation under section 501(a) of such Code) shall not be rendered ineligible for a PPP loan due to ownership by a state or local government if the hospital receives less than 50% of its funding from state or local government sources, exclusive of Medicaid." IHA has been advocating for clarification on the eligibility of Iowa's public hospitals for the PPP loans. With the release of this interim final rule and additional funds provided for the Paycheck Protection Program and Health Care Enhancement Act, IHA encourages public hospitals to work with their lenders to apply for this support.

Federal lawmakers introduce legislation to expand telehealth

Today, Rep. Cindy Axne (D-IA), Rep. Troy Balderson (R-OH) and Rep. French Hill (R-AR) [introduced legislation](#) to expand telehealth availability for those needing important therapeutic services during the COVID-19 pandemic. The Emergency COVID-19 Telehealth Response Act ensures that physical therapists, occupational therapists, speech pathologists, audiologists and clinical social workers can receive telehealth reimbursement from CMS while providing necessary health care services.
