Telehealth parity bill signed into law

Gov. Kim Reynolds signed the tax omnibus bill, [Senate File 619](#), into law on Wednesday. Among the many provisions in the legislation are requirements for telehealth mental health services to be provided at the same rate and in the same manner as if the services were provided in person. The bill also shifts funding for mental health services from the mental health and disability services regions to the state general fund.

The telehealth provision is effective immediately and retroactive to Jan. 1, 2021, and the property tax levy going to the regions for mental health services will be phased out over a two-year period. Payment parity for telehealth and sustainable mental health funding were priorities for the Iowa Hospital Association this legislative session and the association is very pleased to see the bill signed.

IHA would like to thank Gov. Reynolds and the legislators who worked on these issues including Rep. Joel Fry (R-Osceola), Rep. Ann Meyer (R-Fort Dodge) and Sen. Dan Dawson (R-Council Bluffs). Additionally, IHA would like to extend a big thank you to the hospitals and hospital CEOs who advocated to get this legislation passed.

EMS essential service language becomes law

Gov. Kim Reynolds last week signed legislation into law that eases the process for emergency medical services to be declared an essential service. Gov. Reynolds signed [Senate File 615](#), the end-of-year standings legislation, outside of the Monticello Ambulance Service.

A county or city EMS district now can begin the process to declare EMS an essential service without a lengthy petition process to start the declaration. The declaration for counties will remain in place for 10 or 15 years depending on the size of the county.

This was one of IHA's priorities this legislative session. Further details about the language will be included in the Legislative Summary, which will be released following the deadline for all bills to be signed. Questions about this legislation can be emailed to [Erin Cubit](#) at IHA.
