IME updates emergency payment policy

The Iowa Medicaid Enterprise recently updated its emergency payment policy based on IHA and hospital member feedback. The new policy will be effective for dates of service on or after Wednesday, Sept. 1.

Additionally, a claim for emergent service may include an approved emergent diagnosis code in the primary (first) or secondary (second) position to receive the full reimbursement amount. If the primary or secondary diagnosis on the claim is not emergent, the member will be responsible for any applicable copay amount.

Physician Business Leadership Certification Program completed by 14 doctors

IHA congratulates the third cohort of physicians who completed the Physician Business Leadership Certification Program this week. These 14 physicians participated in five days of curriculum that focused on foundational leadership skills, preparation for health care today, and hot topics for providers.

The program included sessions about:

- Advocacy essentials
- Behavioral health
- CEO-CMO partnerships
- Coaching colleagues
- Crisis and grief leadership
- Data-based decision making
- DISC assessments
- Essential job functions of a CMO
- Health care finance
- Managing difficult physicians
- Negotiations and conflict management
- Social determinants of health and population management

This program would not be possible without the support and collaboration of IHA, the Iowa Medical

Society, the Iowa Healthcare Collaborative, and the Iowa Academy of Family Physicians, as well as the guidance of Drs. Tammy Chance with Boone County Hospital and the IHA board, Brian Privett with the Iowa Eye Clinic and IMS board chair, and Tom Evans with the Iowa Healthcare Collaborative who served as program faculty and provided context to connect the topics and issues to Iowa.

Physicians will be recognized at the IHA Annual Meeting in October.



Congress advances infrastructure package

As the Senate works to complete their work before the August recess, the bipartisan infrastructure package made significant advancements Tuesday. The Senate passed a \$1 trillion physical infrastructure deal and will send it to the House for consideration. On Wednesday morning, the Senate passed by a vote of 50-49 a \$3.5 trillion budget resolution triggering work to begin on a human infrastructure package. The House is not expected to take up the initial physical infrastructure bill until the Senate passes the human infrastructure bill, which is expected to be in late September or early October.

The \$1 trillion physical infrastructure package includes funding for broadband internet deployment, equity and affordability as well as investments to improve federal coordination and help with response and recovery from cybersecurity incidents. This package does not include the use of provider relief funds to pay for the provisions within the bill but does extend the Medicare sequester for an additional year, through 2031.

The \$3.5 trillion human infrastructure package includes:

- A continuation of expanded Affordable Care Act subsidies.
- Addressing health care provider shortages through action on the Graduation Medical Education program.
- Addressing inequities in health care.
- An expansion of Medicare to cover hearing, dental, and vision benefits as well as lowering eligibility age.
- Filling the “Medicaid coverage gap.”
- Home health care benefits for seniors and persons with disabilities.
- Reducing prescription drug costs.
- Workforce investments such as the National Health Service Corps, Nurse Corps, and Teaching Health Center Graduate Medical Education.

IHA will continue to follow the progress of both packages and will provide updates as they develop.
