



Contributors who donated \$350 or more to the IHA PAC in 2021 will be invited to an exclusive PAC Leaders session during IHA's 2021 Virtual Annual Meeting at 11:15 am, Tuesday, Oct. 5. The session will feature attorney and author, Gary Ginsberg.

Ginsberg spent his professional career at the intersection of media, politics and law. He worked for the Clinton administration, was a senior editor and counsel at the political magazine, George, and spent two decades in executive positions in media and technology at News Corporation, Time Warner and SoftBank.

During the special PAC session, Ginsberg will discuss his career and his first book, First Friends, that investigates the lives of presidents and how their presidencies were shaped by those they held most dear.

Besides the special session, IHA will recognize three IHA member CEOs for their leadership in advocacy on Thursday, Oct. 7. Each year, the IHA PAC submits nominees to the American Hospital Association Political Action Committee to receive Most Valuable PAC Player (MVPP) and Grassroots Award recognition.

As announced in May, Bill Bumgarner, [Spencer Hospital](#), and Glenn Winekauf, [Horn Memorial Hospital](#), received the MVPP Award, and Kevin Kincaid, [Knoxville Hospital and Clinics](#), received the Grassroots award.

#### IHA Board Chair-Elect

**Brian Dieter – President & CEO | Mary Greeley Medical Center, Ames**

Brian Dieter has been president and chief executive officer of Mary Greeley Medical Center since July 2008. Before this, he was chief financial officer for nine years and spent 10 years at Ancilla Systems at three affiliated health care organizations in financial leadership positions. Dieter holds a bachelor's degree in business from Indiana University and a master's degree in administration from the University of Notre Dame. He is a fellow with the American College of Healthcare Executives. Dieter currently serves as the treasurer of IHA and is the former board chair of the Iowa Hospital Education and Research Foundation.



#### IHA Board Treasurer-Elect

**Robb Gardner - CEO | Henry County Health Center, Mount Pleasant**

Robb Gardner has been chief executive officer of Henry County Health Center since 2009. He has been part of Great River Health since 1998 with roles as physical therapist and athletic trainer, manager of rehabilitation services and director of rehabilitation services. He also serves as vice president of government affairs for Great River Health. Before joining Great River Health, he worked as a physical therapist and athletic trainer at Dean Medical Center in Madison, Wisconsin. Gardner received his bachelor's degree from Luther College, a master's degree in physical therapy from the University of Iowa and a master's degree in health care administration from the University of Minnesota. Gardner has served on the IHA Board since 2015 and is currently the chair for the IHA Council on Health Information. Gardner is active in his community by currently serving on the Mount Pleasant Chamber board of directors and as a member of the Mount Pleasant Noon Rotary Club.

### Iowa House updates: Boussetot wins HD37, special session announced

On Tuesday, voters in Ankeny and rural Polk County selected Republican candidate Mike Boussetot to fill the vacancy in the Iowa House following the passing of Rep. John Landon earlier

this summer. Rep. Bousset is a former adviser and chief of staff to former Gov. Terry Branstad and served as the director of the Iowa Department of Management under Gov. Kim Reynolds. The results from Tuesday's election maintain the current party makeup of the House, with 59 Republicans and 41 Democrats.

Rep. Bousset's victory comes on the same day Gov. Reynolds announced the date of the special election in House District 29 to fill Democratic Rep. Wes Breckenridge's seat as he steps down to take a position at the Iowa Law Enforcement Academy. Voters in Newton, Baxter, Colfax, Mingo, Kellogg, Oakland Acres and Ira will go to the polls Tuesday, Oct. 12.

Gov. Reynolds also signed a proclamation convening a special legislative session beginning Tuesday, Oct. 5. The special session will allow legislators to review and vote on new legislative and congressional districts created by the nonpartisan Legislative Services Agency, as required by the Iowa Code.

It is unknown how long the special session will last or if any other topics will be brought forward for discussion. IHA will monitor developments and provide updates as they occur. Questions about the special session can be emailed to [Erin Cubit](mailto:Erin.Cubit@IHA.org) at IHA.

### **Discover health equity information within IHA data resources in Sept. webinar**

Health equity is an important focus as hospitals and health systems look to the future of the health care landscape. IHA's data resources can help Iowa hospitals close the health equity gap through the new dashboards incorporated into the Dimensions Discovery Data Analytics program.

Dimensions' dashboards include information from resources like the US Census American Community Survey, the Centers for Medicare and Medicaid Services' Hospital Compare and the Robert Wood Johnson Foundation County Health Rankings.

Clinical leaders, Dimensions program leaders, hospital and health system executives and quality professionals can register for IHA's upcoming webinar, **IHA Health Equity Data Resources scheduled from 10-11 am Thursday, Sept. 30.**

Participants will learn how statewide databases allow IHA to analyze patient demographics like race, ethnicity, age, gender and location, and use that information to evaluate and understand their communities' needs.

### **IWD schedules employer roundtables to address worker shortages**

This Tuesday, Iowa Workforce Development (IWD) announced it will hold workforce roundtables statewide to address Iowa's workforce shortage.

More than 25 roundtables are scheduled beginning Sept. 22 and will take place at IowaWORKS field offices and community colleges. Attendees will receive information about existing workforce strategies and resources they can use to grow their staff.

IWD also will have on hand a support team to conduct workforce needs assessments for interested local employees. Participating employers will be provided a customized set of information about relevant state programs and dedicated points of contact.

The roundtables will continue through Monday, Nov. 15.
