Court ruling puts CMS vaccine mandate on temporary hold across the country

On Tuesday, a federal district court in Louisiana issued a [preliminary injunction](#) placing a temporary hold on enforcement of the Centers for Medicare and Medicaid Services' vaccine mandate for health care facilities in all states except for the 10 already covered by Monday's [Missouri district court's preliminary injunction](#).

The federal government is expected to appeal the Louisiana district court's order to the U.S. Court of Appeals for the Fifth Circuit and ask the appeals court to stay the district court's preliminary injunction pending appeal.

On Tuesday, the federal government also appealed the Missouri district court's decision to the U.S. Court of Appeals for the Eighth Circuit and asked the court of appeals to stay the Missouri district court's preliminary injunction pending appeal.

CMS' interim final rule issued last month required workers in most health care settings that participate in Medicare and Medicaid programs to be fully vaccinated against COVID-19 by Jan. 4.

IHA will continue to monitor the situation and provide updates.

Bed tracking report submitted to Iowa Legislature

On Tuesday, Dec. 1, the Iowa Department of Human Services submitted the final report from the Inpatient Bed Tracking Study Committee to the Iowa Legislature. [Senate File 524](#), legislation passed in 2021, directed the department to convene a study committee, which IHA co-chaired and included representation from two hospitals, to develop recommendations for improving Iowa's existing bed tracking system. Legislators will use this report when considering future behavioral health bills. The recommendations presented to the legislature include:

- Enhancing the inpatient bed tracking system.
- Expanding the acuity levels hospitals can treat.
- Increasing reimbursement rates based on level of acuity.

Submit questions for Dec. 15 vaccine mandate webinar

IHA is hosting a webinar on vaccine mandates in two weeks and members are urged to submit questions in advance. Navigating the Legal Uncertainty of COVID-19 Vaccine Mandates in the Health Care Workplace is scheduled from 2-3 p.m. Wednesday, Dec. 15.

Attorney and Drake University associate professor Denise Hill will discuss health care employers' ability to enforce recent federal vaccine mandates considering the recent conflicting recent judicial decisions and state laws. Hill will cover practical legal, risk and compliance strategies hospitals can use to navigate the legal uncertainty and everyday realities surrounding COVID-19 vaccine mandates.

Health care administrators, attorneys, compliance officers, human resource professionals and leaders will gain insight about:

- Assessing the impact of recent judicial decisions and state requirements for hospital vaccines.
- Discussing the risks and benefits of complying with federal COVID-19 vaccine mandates.
- Identifying three strategies for complying with federal vaccine mandates and relevant state laws while minimizing the loss of staff.
- Outlining vaccine mandate standards and determine compliance.

CMS releases implementation guidance for No Surprises Act good faith estimates

The Centers for Medicare and Medicaid Services released 11 documents about its regulations for implementing the No Surprises Act that goes into effect Jan. 1, 2022. The documents include:

- A template of the comprehensive good faith estimate including model disclaimer language.
- Information about the patient-provider resolution process.
- Model language to inform uninsured and self-pay patients of their rights to a good faith estimate.

CMS also released a [memo](#) in late October about the required federal agency contact information and a [website](#) link where they will post documents about the No Surprises Act implementation. The website is live, but CMS notes some functionality will not be available before 2022.

PAMA clinical laboratory data reporting period begins January 2022

The Centers for Medicare and Medicaid Services will require certain hospitals to report private payer rates and volumes for clinical laboratory services covered under the [clinical laboratory fee schedule](#). The next reporting period for hospitals will be Jan. 1-March 31, 2022.

Hospitals will be required to collect and report certain private payer data if Medicare is billed for laboratory services on the CMS 1450 4X Type of Bill 1 and received at least \$12,500 in Medicare revenues from the clinical laboratory fee schedule services. The data collection period is Jan. 1-June 30, 2019. Hospitals will be required to report data about private payer prices and the volume of laboratory services paid at each price.
