## Week 3 summary

Legislative movement picked up during the third week of session. Subcommittee meetings continue to fill IHA's advocacy team calendars as bills move quickly prior to the first funnel. Since this is the second year of a two-year general assembly, the legislative session is scheduled for 100 days. This also means the funnel deadlines are earlier this year than last year with the first funnel deadline in three weeks. The funnel deadlines are self-imposed deadlines for legislators to ensure the legislative process progresses in a timely manner. Below is an update about bills that had activity through the week. - **Companion bill:** [HSB 541](#)
- **What the bill does:** Makes part-time students eligible for Future Ready Last Dollar scholarships.

- **Sponsor:** [Sen. Amy Sinclair](#) (R-Allerton) and College Student Aid.
- **Committee:** Senate Education and House Education.
- **Status:** Both bills passed out of full committee.
- **IHA Position:** IHA supports efforts to expand the health care workforce.

#### [\\*HSB 532](#)

- **What the bill does:** A bill for an act relating to a state-funded psychiatric residency program at the state mental health institutes and the Iowa medical and classification center at Oakdale, creating a program fund and making appropriations.
- **Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).
- **Committee:** House Human Resources.
- **Status:** Passed out of full committee.
- **IHA Position:** IHA supports legislative efforts that expand behavioral health resources in Iowa.

#### [\\*HSB 537](#)

- **What the bill does:** A bill for an act relating to the establishment of a prescribing mental health practitioner loan repayment program and providing an appropriation.
- **Sponsor:** [Rep. Ann Meyer](#) (R-Fort Dodge).
- **Committee:** House Human Resources
- **Status:** Passed out of full committee.
- **IHA Position:** IHA supports efforts to expand the health care workforce and any initiatives that will increase access to behavioral health care.

#### [SSB 3003](#)

- **What the bill does:** A bill for an act establishing the mental health professional loan repayment program within the college student aid commission.
- **Sponsor:** [Sen. Amy Sinclair](#) (R-Allerton).
- **Committee:** Senate Education.
- **Status:** Passed out of subcommittee.
- **IHA Position:** IHA supports efforts to expand the health care workforce and any initiatives that will increase access to behavioral health care.

#### [SF 2046](#)

- **What the bill does:** Requires a health care facility or third-party biller to give a patient an itemized bill on the request of the patient at no charge.
- **Sponsor:** [Sen. Adrian Dickey](#) (R-Packwood).
- **Committee:** Senate Commerce.
- **Status:** Did not pass subcommittee.
- **IHA Position:** IHA supports patients understanding their medical costs, but IHA feels this bill would not achieve that goal with the complexities involved in hospital billing.

#### [HF 656](#)

- **Companion bill:** [SF 2016](#)
- **What the bill does:** Prohibits a health insurance plan from switching drugs without medical necessity (non-medical switching).
- **Sponsor:** House Human Resources Committee and [Sen. Jim Carlin](#) (R-Sioux City)

- **Committee:** House Human Resources and Senate Commerce.
- **Status:** HF 656 passed House subcommittee. SF 2016 did not pass Senate subcommittee but was tabled to discuss later.
- **IHA Position:** IHA's believes medical professionals should be able to determine what is best for their patients without interference from insurance providers.

## HSB 544

- **Companion bill:** \*[SF 2088](#)
- **What the bill does:** A bill for an act relating to the practices of pharmacy and nursing, the administration of immunizations and vaccinations and the licensure of nonresident pharmacies.
- **Sponsor:** House State Government and Board of Pharmacy.
- **Committee:** House State Government and Senate Human Resource.
- **Status:** SF 2088 passed Senate Committee. HSB 544 passed House subcommittee.
- **IHA Position:** IHA is monitoring the status of this bill to learn about the potential impact for hospitals.

## SF 2028

- **What the bill does:** Requires immunization or vaccination of a minor is subject to prior written consent of the minor's parent or legal guardian.
- **Sponsor:** [Sen. Jim Carlin](#) (R-Sioux City).
- **Committee:** Senate Human Resources.
- **Status:** Passed subcommittee
- **IHA Position:** IHA is monitoring the status of this bill but has concerns with the additional burden this unnecessary change would place on health care facilities and providers.

## HF 2010

- **Companion bill:** [SF 2117](#)
- **What the bill does:** Expands the use of experimental treatments for terminally ill persons to include a person on a ventilator and expands to include the off-label use of a drug.
- **Sponsor:** [Rep. Lee Hein](#) (R-Monticello), [Rep. Ann Meyer](#) (R-Fort Dodge) and [Sen. Jeff Edler](#) (R-State Center).
- **Committee:** House Human Resources.
- **Status:** HF 2010 passed House subcommittee. A Senate subcommittee has not been assigned for SF 2117.
- **IHA Position:** IHA is currently monitoring the status of this bill to determine the impact on hospitals.

**DIA state surveys to resume Jan. 31**

As the state hospital surveys are set to resume on Jan. 31, IHA has been in contact with the Department of Inspections and Appeals to encourage continuation of the suspension and ensure the Department has awareness of the situation hospitals are in. IHA also submitted comments to the Centers for Medicare and Medicaid Services urging the continuation of the suspension of surveys, which was declined. The Department of Inspections and Appeals issued the following message:

*On Dec. 27, 2021, the Department of Inspections and Appeals suspended some hospital survey activity through Jan. 30. Based on the guidance of CMS, DIA will resume all regular survey activity on Monday, Jan. 31.*


*For hospitals with concerns that they do not have the capacity to undergo a survey*

and the hospital meets the following:

- More than 80% of ICU beds are in use and more than 35% of those ICU beds in use are due to COVID-19; or
- The information the hospital is reporting to the Iowa Department of Public Health is inaccurate and the hospital's capacity is less than being reported (e.g. a hospital received a large number of staff reporting sick and unable to report to work, and that information was not captured in the report, etc.)

For non-deemed hospitals, requests for survey suspensions should be sent for consideration to the State Survey Agency for consideration. These requests should be emailed to [Christopher Dunn](#) with the Department of Inspections and Appeals. Hospitals deemed through a CMS-approved accrediting organization should contact [their respective accrediting organization](#).

NOTE: The state survey agency or accrediting organization will review the request but may not be able to approve the request based on the information provided. All immediate jeopardy and abuse surveys will be timely conducted regardless of hospital survey activity status in accordance with CMS direction throughout the pandemic.

### CMS releases tools to determine COVID-19 vaccine requirements

After the [Supreme Court's Jan. 13 ruling](#), employee vaccination requirements from the Centers for Medicare and Medicaid Services now apply to certain Medicare and Medicaid providers and suppliers. CMS created and updated tools and resources to help providers and suppliers navigate and determine if vaccine requirements apply.

The resources include:

- **CMS Omnibus COVID-19 Health Care Staff Vaccination Requirements**

**FAQ.** The FAQ was updated to explain the recent ruling and how it affects employee vaccine requirements.

- **Guidance memo.** The memo gives guidance for assessing and maintaining compliance with the new regulatory requirement for certain Medicare and Medicaid providers and suppliers.
- **IFC-6 vaccination requirements infographic.** The infographic shows the types of providers and suppliers the vaccine requirement applies to, how the requirement can be met and associated requirement enforcement actions.
- **Vaccine requirement decision tree.** The flowchart explains the steps to determine to which providers and suppliers the requirement applies.
- **Vaccine requirement implementation timeline.** The chart illustrates the phases of the vaccination rule implementation, state by state and their associated deadlines.
