## WEEKLY SUMMARY

### Week five summary

The first legislative funnel is one week away, which means bills are flying through subcommittee and committee meetings in both chambers. By the end of funnel week, a bill must pass out of a committee in one chamber to be viable for the rest of session.

### Certificate of need

A bill eliminating the certificate-of-need process for hospitals, [Senate Study Bill 3105](#), was introduced and passed through a Senate subcommittee and full committee and will be headed to the full Senate floor. The IHA advocacy team is continuing to work with legislators and providing additional information about the negative impacts this bill would have for hospitals. Thank you to everyone who responded to the IHA action alerts. We continue to hear from legislators that they heard from their respective hospitals about the issue. Your efforts do not go unnoticed. ### Gov. Reynolds' workforce bill

Gov. Kim Reynolds introduced her large workforce bill, [Senate Study Bill 3123](#) and [House Study Bill 682](#), that includes several provisions for health care professionals. Summarized below, the bill enhances the Rural Iowa Primary Care Loan Repayment

Program and the Health Care Loan Repayment Program, which was renamed as the Health Care Award program.

Changes to the Rural Iowa Primary Care Loan Repayment Program:

- Adds advanced registered nurse practitioners and registered nurses to the list of health care professionals who qualify for the program.
- Changes the definition of “eligible institution” to include community colleges.
- Eliminates the Iowa-based residency requirement, allowing part-time practice in a service commitment area to qualify for the program and adds neurology to the list of allowed specialties.

New changes to the Health Care Award Program, formerly the Health Care Loan Repayment Program:

- Allows full-time and part-time practice in the state.
- Qualified applicants no longer must have student loans that need to be repaid – the money can be paid out as an award of up to \$6,000 for a maximum of five consecutive years.
- Requires a part-time nurse educator to also practice as a registered nurse or an advanced registered nurse practitioner to qualify.

### Tort reform

The Senate tort reform bill, [Senate Study Bill 3093](#), passed out of subcommittee this week. IHA is still waiting for the House version to hit the floor’s debate calendar. An action alert about tort reform was sent last week, and IHA encourages our members to continue to reach out to their legislators to keep tort reform moving. ## LEGISLATION ON THE MOVE

### Legislation on the move

#### **\*HSB 638 - Health Worker Employment Agencies**

**Companion bill:** \*[SF 2210](#)

**What the bill does:** Regulates temporary nursing staff agencies by requiring the agencies to register with the state and makes the agencies responsible for maintaining proper credentials and continuing education.

**Sponsor:** Rep. [Ann Meyer](#) (R-Fort Dodge) / Sen. [Jeff Edler](#) (R-State Center).

**Committee:** House Human Resources.

**Status:** Passed out of both the Senate and House committee.

**IHA position:** IHA is monitoring this bill.

#### **[SF 2216](#) - Intensive Psychiatric Care**

**What the bill does:** Establishes state intensive psychiatric units at the state mental health institutes.

**Sponsor:** Sen. [Jeff Edler](#) (R-State Center).

**Committee:** Senate Human Resources.

**Status:** Passed out of Senate subcommittee.

**IHA position:** IHA is monitoring the status of this bill.

#### **\*[HF 2291](#) - Midwife Licensing**

**What the bill does:** Requires practicing midwives to hold a license by July 2023,

establishes requirements and a board, and limits the liability of health care providers who accept transfers of patients from midwives.

**Sponsor:** Rep. [Bobby Kaufmann](#) (R-Wilton).

**Committee:** House State Government and House Ways and Means.

**Status:** Passed out of the State Government subcommittee and committee and referred to the Ways and Means Committee.

**IHA Position:** IHA is not supportive of this bill because of safety and quality concerns.

### **[HSB 650](#) - Prior Authorization**

**What the bill does:** Prohibits a utilization review committee from limiting or revoking a prior authorization after the health care service has been provided.

**Sponsor:** Rep. [Shannon Lundgren](#) (R-Peosta).

**Committee:** House Commerce.

**Status:** Passed a House subcommittee.

**IHA Position:** IHA is supportive of this bill because it will simplify the prior-authorization process.

### **\*[SSB 3118](#) - Newborn Screenings**

Companion bill: [HSB 663](#)

**What the bill does:** Codifies rules on the Congenital and Inherited Disorders Advisory Committee. Requires the advisory committee to recommend to the Iowa Department of Health if new conditions identified by the federal government should be added to the screening panel for newborns.

**Sponsor:** Sen. [Jeff Edler](#) (R-State Center) / Rep. [Ann Meyer](#) (R-Fort Dodge).

**Committee:** Senate Human Resources.

**Status:** Passed out of House and Senate subcommittees.

**IHA position:** IHA is monitoring the status of this bill.

### **[SSB 3128](#) - 340B Drug Program**

**What the bill does:** Prohibits group health plans, other health insurers, third-party administrators and pharmacy benefits managers from discriminating against a contract pharmacy or to impose certain terms solely because a contract pharmacy participates in the 340B drug program.

**Sponsor:** Sen. [Jason Schultz](#) (R-Schleswig).

**Committee:** Senate Commerce.

**Status:** Passed a Senate subcommittee.

**IHA Position:** IHA is supportive of this bill because it will provide some protections for the 340B program.

### **[HF 2267](#) - Newborn Infant**

**What the bill does:** Increases the age of a baby eligible to be dropped off under the newborn safe act to 60 days.

**Sponsor:** Rep. [Jon Jacobsen](#) (R-Council Bluffs).

**Committee:** House Human Resources.

**Status:** Passed a House subcommittee.

**IHA Position:** IHA is monitoring this legislation.

### **[SSB 3116](#) - Mental Health/Disability Services Funding**

**What the bill does:** Allows the cash reserves for a mental health/disability services combined regional account to reach 10% before being disqualified from receiving funding from the mental health/disability services incentive fund.

**Sponsor:** Sen. [Jeff Edler](#) (R-State Center).

**Committee:** Senate Human Resources.

**Status:** Passed out of subcommittee.

**IHA position:** IHA is monitoring this bill.

### **[SF 2159](#) - Assaults on Social Workers**

**What the bill does:** Applies specific penalties to an assault on a social worker under certain circumstances.

**Sponsor:** Sen. [Joe Bolkcom](#) (D-Iowa City).

**Committee:** Senate Judiciary.

**Status:** Passed out of subcommittee.  
**IHA position:** IHA is monitoring this bill.

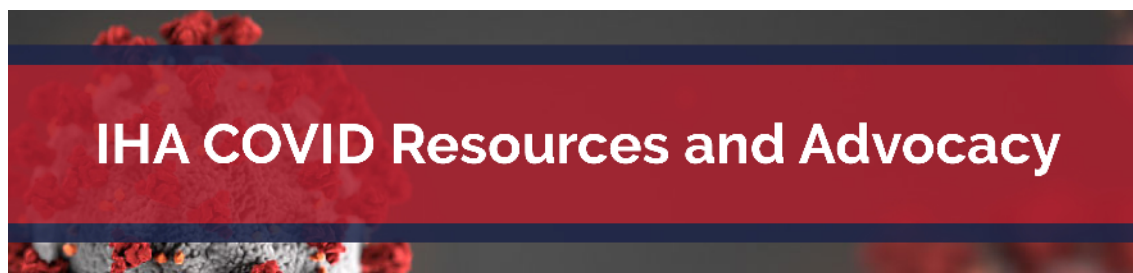

## Board of Medicine announces grace period for medical licensing requirements

Gov. Kim Reynolds recently announced the [state's emergency proclamation will end at 11:50 p.m. Feb. 15](#). While the proclamation is in effect, Iowa rules allowed physicians who hold active medical licenses in other states to practice medicine in Iowa without obtaining an Iowa medical license. When the emergency ends, normal licensure requirements will apply.

To avoid disruptions to staffing and patient care, the Iowa Board of Medicine is authorizing a 90-day grace period to resume compliance with Iowa licensure requirements. Starting Feb. 16, physicians practicing medicine in Iowa based on the emergency proclamation will have until May 17 (90 days) to obtain proper licensure. ## IDPH provides pediatric vaccine info in anticipation of FDA approval

To prepare for the potential emergency-use authorization of a Pfizer-BioNTech pediatric COVID-19 vaccine series for children 6 months to 4 years old, the Iowa Department of Public Health is providing information to help health care providers for a future rollout. This includes information about:

- Pediatric ancillary kits.
- Pfizer pediatric vaccine formulation.
- Vaccine storage and handling.

The Food and Drug Administration is [delaying the Feb. 15 virtual meeting](#) of its vaccine and related biological products advisory committee where members would have discussed the vaccine. The FDA said Pfizer told the agency new data recently emerged and more time is needed to evaluate it.

*Pediatric Pfizer vaccinations for children 6 months to 4 years old cannot begin until after FDA emergency-use authorization approval and Advisory Committee on Immunization Practices recommendations are signed by the Centers for Disease Control and Prevention's director.*

### **New HCPCS code for convalescent plasma in the outpatient setting**

On Dec. 28, the Food and Drug Administration revised the [emergency-use authorization](#) for COVID-19 convalescent plasma with high titers of anti-SARS-CoV-2 antibodies. It is authorized for the treatment of COVID-19 in patients with immunosuppressive disease or getting immunosuppressive treatment in both outpatient and inpatient settings.

The Centers for Medicare and Medicaid Services created HCPCS code C9507 for convalescent plasma for use in the outpatient setting, effective on or after Dec. 28:

- Long descriptor: Fresh frozen plasma, high titer COVID-19 convalescent, frozen within eight hours of collection, each unit.
- Short descriptor: COVID-19 convalescent plasma.

### **Registration open for two-part series about No Surprises Act**

The federal No Surprises Act went into effect Jan. 1. The two-part webinar The No Surprises Act Is Here: Compliance Obligations and Strategic Planning for Hospitals will discuss the immediate obligations for hospitals and other providers.

Topics discussed will include:

- Notice and consent requirements for when care is provided by out-of-network clinicians at in-network facilities.
- Obligations to provide good faith estimates for self-pay and uninsured patients.
- Rules about emergency services and post-stabilization care at hospitals or freestanding emergency departments.
