### **Nomination**

I have had the opportunity to work with Ken since his appointment to the Mary Greeley Medical Center board of trustees in 2004, initially in my role as vice president and chief financial officer, then since 2008 in my current role at president and CEO. When the Sarbanes-Oxley Act passed in 2002, leading health care governance advisers suggested that the addition of a trustee with an extensive and varied financial background would be a wise move. Ken was recommended and, fortunately for Mary Greeley, agreed to accept an appointment to the board. The hospital was even more fortunate when Ken chose to run for reelection to the board and has continued to do so every four years since 2006.

Ken is the Mary Greeley Medical Center board chair and treasurer, as well as chair of the Finance and Audit Committee and the Governance and Compensation Committee. In addition, Ken is on the American Hospital Association Regional Policy Board 6. He has been on the governance planning committee and is on the Council on Education and Member Services for the Iowa Hospital Association. Ken has maintained his IHA certification as a trustee since its inception. Before his retirement from Sauer-Danfoss, Ken served as Board and Audit Committee Secretary, Chair of UK Pension Plan Trustees and the board of directors and officers of various United States, Canadian and European companies. He also has served on many local community service boards including the United Way of Story County, the Ames Educational Foundation and the Ames City Vision Committee.

Ken exemplifies the best in health care governance. He is a strategic thinker, a diplomat, a visionary and a leader. He is experienced, fair and ethical. He is proficient as a discussion leader and facilitator. Ken is supportive of Mary Greeley's objectives and vision and demonstrates both the personal and professional attributes that his position on the board entails. His extensive financial background provides a level of expertise that is an asset to any organization. Ken has served as a mentor to less-experienced members of the board. It is my pleasure to write this letter of support for Kenneth McCuskey for the IHA Excellence of Governance Award. As a member of the Mary Greeley Medical Center's Board Finance and Audit Committee for the past eight years, I have witnessed Ken's proactive, engaging leadership style and appreciate how it contributes to enhanced health care services in Ames and the surrounding area.

I retired as vice president of a Fortune 100 manufacturing firm and served on several nonprofit boards. Ken possesses the qualities I've witnessed in effective leaders. Four qualities stand out as I have observed him interact with Mary Greeley Medical Center (MGMC) management and board members to achieve its strategic goals, serve the community and be a leading health care provider in the region:

- 1. *Engaging Leader* Ken's self-depreciating leadership style is particularly effective in building teamwork to reach decisions and deliver results. He mentors others to set high standards for achievement and accountability for outcomes. In addition, Ken is forward thinking. He proactively follows current events that shape the future of the health care industry and keeps these issues in front of the organization. Examples include:
  - a. As chair of the MGMC Board's Finance Committee, Ken requested the information technology staff and its external security audit firm to provide regular cybersecurity updates to the Finance Committee to ensure oversight in this everchanging environment.
  - b. Hospital consolidations, the Patient Protection and Affordable health care Act, new technology, Iowa's Medicaid Program and heart/dialysis/ambulatory surgery centers offer unique challenges. Ken consistently encourages the organization to be prepared to either minimize the impact or maximize the opportunities these trends present.
- 2. *Pragmatic Thinker* Ken is adept in analyzing a situation, asking probing questions and weighing the consequences. He seeks to understand both the theoretical and practical side to any problem and appropriately comes to a balanced solution. The COVID-19

- pandemic presented many new and different opportunities to exercise these skills. For example, the COVID-19 pandemic was particularly impactful on MGMC's financial results. Ken quickly grasped financial targets needed to be flexible in a rapidly changing environment; yet, challenging to ensure accountability and financial excellence.
- 3. *Collaborative Problem Solver* Ken values teamwork and diverse opinions. When faced with a decision, he engages all the stakeholders. Ken instinctively solicits input from management, Board members and others to build consensus decision-making. For example, in 2020-2021, Mary Greeley faced a financial reporting decision related to the CARES Act. Generally Accepted Accounting Standards for the CARES Act payments are different for government and public entities. Following the Government Accounting Standards Board standards distorted benchmark information with Financial Accounting Standards Board entities. Ken sought input from management, board finance committee members and outside auditors to build a consensus solution.
- 4. *Civic Minded* Ken supports initiatives that bind the Mary Greeley Medical Center to the surrounding community. As a Mary Greeley Medical Center board trustee, Ken has proactively supported construction or renovation projects totaling more than \$150 million to create an innovative and efficient building to deliver high quality health care in the region. Ken has also supported initiatives that enhance health within the community such as a Story County Healthy Life Center and new health care services, such as a psychiatric program and a wound care clinic.

In summary, Ken is a tremendous asset to the City of Ames and Story County. His dedicated service and contributions to Mary Greeley Medical Center's success and to the surrounding community makes him an excellent candidate for the IHA Excellence of Governance Award.

Mindful of his role in governance versus management, he offered great support and advice to the management team as they navigated the complexities of hospital finance. I particularly noted his meticulous oversight of the audit and budget process, his insight in investing, borrowing, bond issuing, joint ventures, facility

enhancements, employee benefits, etc. I also remember specifically his steady hand during the 2008 recession when he reminded us that tough times can prompt novel solutions.

Besides his financial expertise, Ken's experience with teamwork, compliance, process improvement, and error reduction in industry provided a unique perspective to all the quality improvement efforts at Mary Greeley.
