## U.S. Senate passes Inflation Reduction Act

The U.S. Senate included several health care provisions in the [Inflation Reduction Act of 2022 \(H.R. 5376\)](#). The bill is a roughly \$700 billion social spending package and includes climate change and tax provisions.

### [Health care highlights include:](#)

- **Allowing Medicare to negotiate drug prices** on a limited set of drugs, including insulin. The government and pharmaceutical companies can establish prices for a subset of higher cost, sole source drugs covered through Medicare Part B and Part D. The price negotiated between the government and manufacturer must be lower than a ceiling price based on a formula in the law.
- **Extending the expanded eligibility and value of the Affordable Care Act Marketplace** subsidies authorized through the American Rescue Plan Act for three years. The American Rescue Plan Act expanded eligibility for subsidies to people above 400% of the federal poverty level and lowered the premium percentage at every income level.

IHA is pleased to see the Senate take steps to make health care more accessible to low- and middle-income families through the Affordable Care Act and is taking steps to lower prescription drug costs for Medicare patients.

Other provisions include:

- Addressing climate change through a combination of tax changes and spending subsidies.
- Imposing a 15% corporate tax minimum.
- Including polices to address carbon emissions.
- Investing in domestic energy production and manufacturing.
- Providing \$80 billion over the next 10 years for tax enforcement and

compliance.

- Reducing the deficit.

The bill was passed in the Senate 51-50 and was considered under reconciliation procedures. It was amended during floor debate and will likely be considered by the U.S. House of Representatives Friday, Aug. 12.

### Hospitals can now review COVID-19 personnel vaccination data

Hospitals, inpatient psychiatric facilities and prospective payment system-exempt cancer hospitals have until Tuesday, Aug. 30, to review their data for the [October Update to Care Compare](#). For hospitals participating in the inpatient quality reporting program, the October refresh will include data about the health care personnel COVID-19 vaccination measure. The posted data will reflect hospital performance from October-December 2021.
