Pediatric surge starting in Iowa

IHA is convening a weekly pediatric surge partner meeting to discuss concerns about the pediatric surge seen in the state. Many children are being treated for RSV, flu and COVID-19.

IHA releases latest hospital data trends

IHA has collected data trends from [99 hospitals for January-September 2022](#) as compared with the same time frame in 2021:

- Acute discharges decreased 2.4% as acute patient days increased 2.1%.
- Hospital-based ambulatory surgery visits increased 3.1%.
- Average facility paid hours increased 8%.
- Average length of stay increased 4.1%.
- Average physician paid hours increased 19.6%.
- Births increased 3.9%.
- Charity care decreased 8.5%.
- Emergency department visits increased 3.6%.
- Facility employment (excluding physicians) increased 8.1%.
- Inpatient surgeries decreased 17.7%.
- Inpatient admissions from the emergency department decreased 2.2%.
- Medicaid acute discharges decreased 5.1% and Medicaid acute patient days decreased 0.5%.
- Net patient revenue (collected charges) increased 3.6%.
- Outpatient utilization increased 7.5%.
- Payroll and benefits expense increased 11.9%.
- Total average paid hours increased 11.1%.

- Total expenses increased 7.5%.
- Uncompensated care (bad debts) increased 14.4%.

COPIC releases booklet about navigating law enforcement encounters
